



## RESOLUTION NO.

### OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

#### RESOLUTION ADOPTING THE SECURED PROPERTY TAX ROLL TAX RATES FOR FISCAL YEAR 2009/10

**WHEREAS**, Government Code §29100 requires the Board of Supervisors to adopt by resolution the rates of taxes on the secured roll on or before the first business day of September of each year. Government Code §29100 also allows for the permanent extension of the resolution to adopt the rates to each October 3. The Board of Supervisors adopted such an extension via Resolution 246-95 on August 29, 1995.

**NOW, THEREFORE, BE IT RESOLVED** the Board of Supervisors establishes the following tax rates on the secured tax roll for the fiscal year July 1, 2009 - June 30, 2010:
