To the El Dorado County Board of Supervisors,

I am writing to raise concerns regarding the agendized hearing for TM24-0001 / Z24-0001 / PD24-0001 (Serrano Village M5), scheduled for July 30, 2024. The El Dorado County Planning Commission formally reviewed and denied this project on March 14, 2024, based on substantial findings, including inconsistency with the El Dorado Hills Specific Plan, proposed density that exceeds what is appropriate for the surrounding neighborhood, and a lack of adequate justification for a Planned Development.

To date, no public record shows that an appeal of that denial was filed by the applicant within the timeframes and procedures established by County ordinance. In the absence of an appeal, it is unclear why this project is being placed before the Board for action at all. Every other land use applicant in this county is required to follow proper process, including Planning Commission review, timely appeals, and adherence to adopted land use procedures. This project should be no exception.

The appearance that a denied project can simply be reintroduced without an appeal undermines public trust in the integrity and fairness of El Dorado County's land use process. If the Board proceeds with hearing this matter, the County owes the public a clear explanation of the procedural authority that allows it to bypass the standard appeal requirement.

I respectfully urge the Board to uphold the integrity of its own policies and procedures by either declining to hear the project absent a proper appeal, or by formally articulating the process under which this item has been brought forward despite the Planning Commission's denial.
