Honorable Planning Commissioners,

The Cameron Park Community Services District (CPCSD) appreciates the opportunity to provide comments regarding the proposed Town & Country Village El Dorado project. As the local government agency providing parks, recreation, fire protection, solid waste, and community services to over 19,000 residents, we are responsible for ensuring that new growth is planned responsibly and that community services are supported in a fair and sustainable manner.

While this project is outside of our District's boundaries, our Community Center, Aquatics Center, and Christa McAullife Park are located just 1.9 miles away, a four-minute drive from the project site. The proximity of this development makes it especially important for CPCSD to understand and plan for potential impacts on our facilities and services. At the same time, the District remains concerned about the added demands this project may place on CPCSD resources. To maintain essential services for our community, it is critical that these impacts are fully discussed and mitigated.

Community Impacts to CPCSD Facilities

The Cameron Park Community Services District and El Dorado Hills Community Services District Parks and Recreation Facilities Demand Assessment (Final Report, March 10, 2025) documents how CPCSD facilities are already functioning as regional recreation destinations.

Cameron Park Lake, which offers numerous amenities including access to the Bonanza Park Disc Golf Course, is the District's largest facility and attracts tens of thousands of visitors annually. Rasmussen Park and Christa McAuliffe Park also receive high levels of use, both from casual visitors and organized activities such as softball, baseball, and soccer. Over ten sports clubs from Cameron Park and El Dorado Hills regularly use these fields, and the Community Center pool supports two competitive swimming clubs.

As part of the assessment, CPCSD and EDHCSD coordinated to develop data-driven estimates of park visitors using the Placer Labs, Inc. "Placer.ai" software platform, which leverages anonymized mobile location data to analyze trip origins, destinations, frequency, and trends. The analysis confirms:

- Cameron Park Lake received 75,000 visits in 2024, with nearly 40% of visitors coming from outside Cameron Park, including 10% from Rescue and almost 40% from other regional locations.
- The Aquatics Center recorded 20,400 visits, with nearly 25% from El Dorado Hills and 26% from outside communities.
- Christa McAuliffe Park drew 47,100 visits, with 32% from outside Cameron Park, including more than 14% from El Dorado Hills.

This data clearly shows that CPCSD already bears the burden of substantial non-resident demand. The introduction of Town & Country Village will intensify these impacts, further stressing CPCSD's parks, sports fields, aquatics, and community facilities. Without mitigation, the cost burden for increased maintenance and operations will fall disproportionately on current Cameron Park residents.

Project-Specific Concerns

The Planned Development (PD) application includes several components with significant community service implications:

- 112 multi-family cottages, divided between:
 - 56 designated for resort staff housing, and
 - 56 luxury hotel cottages, subject to a Conditional Use Permit.
- **Two hotels**, which will bring additional overnight visitors into the area.
- An event center, which will host large gatherings, conferences, weddings, and community events, generating substantial traffic and episodic service demand.

Each of these uses creates distinct service pressures. Staff housing will introduce permanent residents who will rely on CPCSD parks, recreation, and fire services. The luxury cottages and hotels will generate transient visitation, further stressing CPCSD facilities already serving large numbers of non-residents. The event center will introduce episodic but high-volume demands, with potential spillover effects on parking, traffic, and recreation facility usage before and after events.

Program Study Area

For CEQA purposes, the County also evaluated a broader "**Program Study Area**" associated with Town & Country Village, including:

- 150 senior units
- 200 apartments above retail

• 352 for-sale townhomes

This scenario represents over 700 additional residential units. While not part of the immediate PD application, these units underscore the project's long-term potential to add significant population to the region. Should these future components proceed, CPCSD services will face further increased demand. It is critical that the Planning Commission account for these cumulative impacts in conditioning approvals.

Request for Planning Commission Action

To ensure fairness and sustainability, CPCSD respectfully requests that the Planning Commission condition any approval of Town & Country Village El Dorado on:

- Park and Recreation Mitigation Require fair-share contributions proportionate
 to the projected regional use of CPCSD parks, sports fields, aquatics, and
 recreation facilities as calculated by the impact of the PD, as well as the Program
 Study Area.
- 2. **Equivalent Funding** Provide an enforceable mechanism for both one-time facility improvements and ongoing maintenance revenues.
- 3. **Monitoring and Enforcement** Incorporate enforceable conditions so that mitigation measures are implemented and maintained over the life of the project.

Conclusion

The Town & Country Village project, as currently proposed, has the potential to significantly affect CPCSD's ability to provide quality parks, recreation, and fire services. The District supports thoughtful growth but emphasizes that such growth must be accompanied by fair-share contributions that prevent existing Cameron Park residents from subsidizing new development. The CPCSD cannot support a project that does not adequately address the concerns brought forth in this letter.

We appreciate your careful consideration of these issues and look forward to continuing to work collaboratively with the County, project applicants, and community stakeholders.





Commissioners,

I vigorously oppose amending the general plan to allow housing on this site because no mechanism is in place to provide reasonable assurance that the traffic impacts and adverse financial impacts to the Cameron Park CSD will be mitigated. I wrote Planning and the applicant eleven months ago pointing out that the Fiscal Impact Analysis failed to identify the adverse effects on the Cameron Park CSD. Page 6 of Staff Exhibit R, Local Traffic Analysis, points out that a number of traffic abatement measures are unfunded.

The County would likely benefit from the tax revenues collected by the proposed hotel, however there is no guarantee that a hotel will ever be built. There is the possibility that the hotel will never come to fruition, but the general plan will be amended to allow for multifamily housing on this site.

In the late 1980s, the public was promised a four lane Bass Lake Road and growth was approved based on that promise. In the 1990s, the public was promised a four lane Bass Lake Road and the Bass Lake Specific Plan was approved based on that promise. I urge that the Planning Commission use great restraint as you consider recommending the approval of additional growth until there is a great deal of certainty that dramatic capacity improvements are made to Bass Lake Road, the Bass Lake Interchange, and Highway 50.

Also, APAC's position regarding the connection to EID sewer service prior to issuance of any building permits is spot on.


