

SECOND AMENDMENT TO AGREEMENT FOR SERVICES #7565

THIS SECOND AMENDMENT to that Agreement for Services # 7565 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Jonathan Sheinberg, an individual, doing business as JS MD SIGMA, whose principal place of business in the State of California, whose principal place of business is 4285 CR 3270, Kempner, Texas 76539 (hereinafter referred to as "Consultant");

RECITALS

WHEREAS, Consultant has been engaged by County to provide cardiovascular and metabolic screening to Sheriff's Office staff pursuant to Agreement for Services #7565, dated March 21, 2023, and Amendment I, dated June 11, 2024, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to reflect a change in the name and form of the company from Sigma Wellness LLC., a Texas limited liability company, to Jonathan Sheinberg, an individual, doing business as JS MD SIGMA;

WHEREAS, the parties hereto desire to amend the Agreement to update the Notices to Consultant address, amending **ARTICLE XIV Notice to Parties**;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Consultant mutually agree to amend the terms of the Agreement in this Second Amendment to Agreement on the following terms and conditions:

- I. **Company Name Change:** The name "Sigma Wellness LLC" wherever it appears in the Agreement #7565, and Amendment I, dated March 21, 2023, and June 11, 2024, respectively, shall be replaced with "Jonathan Sheinberg, doing business as JS MD SIGMA". This includes, but is not limited to, all references to "Sigma Wellness LLC" in the introductory paragraph, preamble, signatures and throughout the body of the Agreement. All references in the Agreement and Amendment I to "Sigma Wellness LLC, a Texas limited liability company" shall be deemed to refer to Jonathan Sheinberg, an individual, doing business as JS MD SIGMA, and Jonathan Sheinberg expressly assumes all obligations of Sigma Wellness LLC under the Agreement, Amendment I, and this Amendment.
- II. **ARTICLE XIV**
Notices to Parties: Notices to Consultant is amended in its entirety to read as follows:

Exhibit A
California Levine Act Statement

California Levine Act Statement

California Government Code section 84308, commonly referred to as the "Levine Act," prohibits any officer of El Dorado County from participating in any action related to a contract if he or she accepts, solicits, or directs any political contributions totaling more than two hundred and fifty dollars (\$250) within the previous twelve (12) months, and for twelve (12) months following the date a final decision concerning the contract has been made, from the person or company awarded the contract. The Levine Act also requires disclosure of such contribution by a party to be awarded a specific contract. An officer of El Dorado County includes the Board of Supervisors, any elected official, and the chief administrative officer (collectively "Officer"). It is the Contractor's responsibility to confirm the appropriate "Officer" and name the individual(s) in their disclosure.
