The County of El Dorado Board of Supervisors will hold a public hearing in the Supervisors Meeting Room, 330 Fair Lane, Placerville, CA 95667 on October 20, 2020 at 2:00 p.m., to consider Parcel Map Amendment P-C20-0001/O'Daly Parcel Map Amendment submitted by LISA O'DALY requesting to amend recorded Subdivision Map C-56B to reduce an existing Setback Line from 20 feet to 0 (zero) feet. The property, identified by Assessor's Parcel Number 033-424-006, consisting of 0.25 acre, is located on the east side of Delaware Street, approximately 2,640 feet north of the intersection with North Upper Truckee Road, in the South Lake Tahoe Area, Supervisorial District 5.
