

This Amendment I to that Agreement for Services #276-S0711, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Aon Consulting, Inc., a New Jersey Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 199 Fremont Street, Suite 1400, San Francisco, CA 94105; (hereinafter referred to as "Consultant");

RECITALS

WHEREAS, Consultant has been engaged by County to provide employee benefit consulting services for the Human Resources Department, Risk Management Division, in accordance with Agreement for Services #276-S0711, dated November 14, 2006, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to extend the term of said Agreement, hereby amending ARTICLE II - Term; and

WHEREAS, the parties hereto have mutually agreed to amend ARTICLE X – Notice to Parties; and

NOW THEREFORE, the parties do hereby agree that Agreement for Services #276-S0711 shall be amended a first time as follows:

ARTICLE II

Term: This Agreement, as amended, shall become effective upon execution by both parties hereto and shall cover the period of November 26, 2006 through January 31, 2010.

ARTICLE X
