[23-1391](#) Cameron Park Design Review Committee to review and make recommendations regarding the landscape plans, elevation, color samples, fencing and signage for the following project: CUP22-0003 - CAMERON PARK SELF STORAGE (Gill Gurmukh/ARE Associates-Ken Carrell): A Conditional Use Permit request to develop and operate a new 191-unit self-storage facility. The property, identified by Assessor's Parcel Number 083-112-018, consists of 2.02 acres, and is located on the north side of Camerado Drive, approximately 35 feet northwest of the intersection with Cameron Park Drive, in the Cameron Park area, Supervisorial District 2. This item is a follow up to agenda item 2 from the June 26, 2023 meeting.

[23-0891](#) Cameron Park Design Review Committee to review and make recommendations regarding the following project: DR22-0005 - LA CRESCENTA SIX-PLEX (Aqeel Mohammad/Saturn Real Estate Investment, LLC/Shalanda White-Christian): A Design Review request to propose a six-plex apartment building. The project would include the construction of a two-story, six-plex apartment complex with one- and two-bedroom units. One and two car garages will be attached to each unit. The first-floor units shall be ADA compliant along with the private patio, storage, trash receptacle enclosure and landscaping. The property, identified by Assessor's Parcel Number 083-052-005, consists of 0.37 acres, and is located on the west side of La Crescenta Drive, approximately 600 feet southwest of the intersection with Green Valley Road, in the Shingle Springs area, Supervisorial District 2.
