

AGREEMENT FOR SERVICES #049-S0810
AMENDMENT I

This Amendment I to that Agreement for Services #049-S0810, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Loomis, Fargo & Co., a Texas Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 2500 City West Blvd., Suite 900, Houston, TX 77042, and whose local place of business is 315 12th Street, Sacramento, CA 95814; (hereinafter referred to as "Contractor");

WITNESSETH

WHEREAS, Contractor has been engaged by County to provide conjunctive, sequential, on route pickup and delivery of items from the El Dorado County Treasurer's office to/from the County's designated, mutually agreed-upon location(s), in accordance with following agreement documents. The Agreement documents shall consist of the following made by reference a part hereof, and any inconsistency among these various Agreement documents or interpretation of this Agreement shall be resolved by giving the greatest weight to the documents in the order in which they are listed (the first listed being given the greatest weight):

1. Amendment I of Agreement for Services #049-S0810;
2. Agreement for Services #049-S0810 and Additional Terms and Conditions dated July 23, 2007;
3. Armored Car Service Agreement # 049-S0810, dated July 23, 2007

Notwithstanding any other terms and conditions contained herein, the following terms and conditions shall be incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to update the **COMPENSATION** clause of said Agreement; and

WHEREAS, the parties hereto have mutually agreed to update the **ADMINISTRATOR** clause of said Agreement; and

NOW THEREFORE, the parties do hereby agree that Agreement for Services #049-S0810 shall be amended a first time as follows:

COMPENSATION: The total amount of this Agreement shall not exceed \$9,000 per annum, inclusive of all expenses.

ADMINISTRATOR: The County Officer or employee with responsibility for administering this Agreement is Louise Gresham, Assistant Treasurer/Tax Collector, or successor.

Except as herein amended, all other parts and sections of that Agreement #049-S0810 shall remain unchanged and in full force and effect.
