I was just informed that we need to correct the funding table data in this document. We need to pull the item to make minor revisions to the funding table exhibit. The best solution is to reschedule this item for 9/10/13 Agenda. I can probably have corrected exhibit information ready by tomorrow, but that is last minute.

This item is an amendment to the previously executed Cooperative Agreement for Northside School Bike Path Project. The main purpose of the amendment was to list a late grant received for the project just prior to going to construction. We recently received a Federal Public Lands Highway Discretionary (PLHD) grant fund, \$300,000. This will replace Local dollars budgeted toward project. During the process of getting this grant we also had to shift federal grant funds off of our utility relocation work because of a new "Buy America" steel requirement for utility companies. The utility work and cost for this project was completed during the project's prior right of way phase. The revisions we need to make to the table are related to showing the right of way cost and funds for project. The \$300k grant and sum of multiple other grant fund source contributions stay the same on project. The proposed late revisions to this agenda item exhibit is to show the right of way cost and funds differently now.
