



RESOLUTION NO. 008-2010

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

AUTHORIZING EXECUTION OF STANDARD AGREEMENT 10F-4010 WITH THE CALIFORNIA DEPARTMENT OF COMMUNITY SERVICES AND DEVELOPMENT FOR COMMUNITY SERVICES BLOCK GRANT (CSBG) SERVICES

WHEREAS, the State of California Department of Community Services and Development has offered Contract No. 10F-4010 to the County of El Dorado and has initially made funds available in the amount of \$21,675, a portion of the projected total allocation of \$255,475, through said Contract for Community Services Block Grant services during the period January 1, 2010 through December 31, 2010; and

WHEREAS, the El Dorado County Board of Supervisors has designated the El Dorado County Department of Human Services to administer programs on behalf of the County that benefit low-income populations and is willing to accept the aforementioned contract; and

WHEREAS, should El Dorado County accept Contract No. 10F-4010 from the California Department of Community Services and Development, the County certifies that all uses of funds will be in compliance with Department of Community Services and Development regulations, guidelines and contract provisions; and

WHEREAS, the Chairman of the Board can act on behalf of the County of El Dorado and shall sign all necessary documents required to complete the contract;

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Supervisors of the County of El Dorado hereby authorizes the Chairman of the Board to execute Contract No. 10F-4010 with the California Department of Community Services and Development, for the period January 1, 2010 through December 31, 2010, in the amount of \$21,675, for the provision of Community Services Block Grant (CSBG) services in accordance with the 2010-11 CSBG Community Action Plan and further authorizes the Director of the El Dorado County Department of Human Services, or successor, to execute further documents relating to Contract No. 10F-4010, including one or more amendments thereto, contingent upon approval by County Counsel and Risk Management, that collectively increase the dollar amount by up to \$233,800 to the total estimated 2010 allocation of \$255,475, other amendments thereto that do not alter the total maximum dollar amount or term, to sign subsequent required fiscal and programmatic reports and to perform any and all administrative responsibilities in relationship to said contract.
