#### **RECOMMENDATION:**

The Department of General Services recommends the Board of Supervisors:

- 1. Approve the Amendment I Fixed Base Operator Agreement Lease #560-L0311 between the County of El Dorado, as Lessor and Steven P. Bonak, dba, Placerville Aviation, as Lessee, and;
- 2. Authorize the Chairman to execute said Amendment.

#### **REASON FOR RECOMMENDATION:**

Mr. Bonak had originally anticipated building a nine thousand six hundred square foot (9,600) hangar; however, due to the high cost of building supplies he had to reduce the size to seven thousand two hundred square feet (7,200), thus requiring an amendment to his original Lease Agreement with the County of El Dorado.

The County officer or employee with responsibility for administering this lease is Joanne M. Narloch, Director, General Services Department, or successor.

County Counsel and Risk Management have approved the lease, and a copy is on file in the Board Clerk's Office.

#### **FISCAL IMPACT:**

The financial impact related to this Amendment involves a reduction in revenue of approximately \$2,016.00 year.
