

## **RESOLUTION NO.**

## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

**WHEREAS**, in accordance with Section 604 of the County of El Dorado Personnel Rules Resolution #166-2022 applicable to represented and unrepresented employees, and Section 601 of the El Dorado County Salary and Benefits Resolution **#XXX-2024** applicable to unrepresented employees, the Board of Supervisors shall by Resolution establish the salary for all authorized positions within the County; and

**NOW, THEREFORE, BE IT RESOLVED,** the Board of Supervisors of the County of El Dorado authorizes the Director of Human Resources to make any technical corrections if needed.

**BE IT FURTHER RESOLVED,** that, notwithstanding any contrary provision of Resolution **#XXX-2024**, the Board of Supervisors of the County of El Dorado does hereby authorize Administrative Management (UM) employees to receive, upon the employee's request, a one-time payment for any unused Management Leave up to forty (40) hours for a full-time continuing employee, for calendar year 2025 only; part-time and mid-year hires may receive payment for up to half of their total unused 2025 Management Leave. An eligible employee shall make their request by pay period 25 of 2025; payment shall be made at the employee's base hourly rate at the time such payment is made.

**BE IT FURTHER RESOLVED,** that, notwithstanding any contrary provision of Resolution **#XXX-2024**, the Board of Supervisors of the County of El Dorado does hereby authorize Exempt Confidential (CO) employees to receive, upon the employee's request, a one-time payment for any unused Special Leave up to twenty-eight (28) hours for a full-time continuing employee, for calendar year 2025 only; part-time and mid-year hires may receive payment for up to half of their total unused 2025 Special Leave. An eligible employee shall make their request by pay period 25 of 2025; payment shall be made at the employee's base hourly rate at the time such payment is made.

**BE IT FURTHER RESOLVED,** that, notwithstanding any contrary provision of Resolution **#XXX-2024**, the Board of Supervisors of the County of El Dorado does hereby authorize Non-Exempt Confidential (CO) employees to receive, upon the employee's request, a one-time payment for any unused Special Leave up to sixteen (16) hours for a full-time continuing employee, for calendar year 2025 only; part-time and mid-year hires may receive payment for up to half of their total unused 2025 Special Leave. An eligible employee shall make their request by pay period 25 of 2025; payment shall be made at the employee's base hourly rate at the time such payment is made.

**BE IT FURTHER RESOLVED,** that the first full pay period following Board of Supervisors adoption of this Resolution, the County will pay each employee who is in a classification that is represented by a recognized employee organization but where the employee's position is designated as Confidential (CO), a one thousand dollar (\$1,000.00) lump sum payment minus applicable payroll deductions as required by law, provided the employee has not otherwise received a lump sum payment associated with that recognized employee organization in the last twelve (12) months.
