

AGREEMENT FOR SERVICES #097-110-P-E2010
AMENDMENT III

This Amendment III to that Agreement for Services #097-110-P-E2010, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as COUNTY) and Progress House, Inc., whose principal place of business is 2844 Coloma Street, Placerville, CA 95667; (hereinafter referred to as CONTRACTOR).

R E C I T A L S

WHEREAS, CONTRACTOR has been engaged by COUNTY to provide alcohol and other drug treatment services, in accordance with Agreement for Services #097-110-P-E2010, dated May 12, 2010; Amendment I to that Agreement dated December 7, 2010; and Amendment II to that Agreement dated November 15, 2011, incorporated herein and made by reference a part hereof; and

WHEREAS, the Health Services Department been reorganized and is now known as Health Services, a Department of the Health and Human Services Agency; and

WHEREAS, the Department has identified unspent Substance Abuse Prevention and Treatment (SAPT) funding and desires to make it available for counseling and treatment services, thereby amending Article IV – Compensation for Services, Section 4.02 – Amount of Funding, subparagraph (a) (ii); and

WHEREAS, the parties hereto have mutually agreed to update contact information to coincide with the reorganization of the Health Services Department, thereby amending Article XVIII – Notice to Parties;

NOW THEREFORE, the parties do hereby agree that Agreement for Services #097-110-P-E2010 shall be amended a third time as follows:

- 1) All references in the original agreement to the “County Health Services Department” or “HSD” shall be deemed to refer to the Health Services, a Department of the Health and Human Services Agency.
- 2) Article IV, Section 4.02 (a) (ii) shall be amended in its entirety to read as follows:

- (i) For the term July 1, 2011 through June 30, 2012 is set forth below, by funding type:
