Would also like more information about how the Mobile Crisis Unit will address need for twenty-four-seven crisis line, as well as needs for South Lake Tahoe area. Wonders if comment regarding Clubhouse funding shifting from PEI to CSS is feasible.*

*Meredith Zanardi, MHSA Program Coordinator: Answers looking forward to more collaboration with EDCOE regarding a plan moving forward with continued funding changes. Answers a contract has been solicited for and awarded to a Community provider, Sierra Mental Wellness Group, who will be operating twenty-four-seven in the South Lake Tahoe Basin and will also be operating after hours and on holidays on the West Slope. Answers comment regarding Clubhouse funding will be taken back for review and consideration.*
