Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on February 9, 2023, at 8:30 a.m., to consider the following: Tentative Map Time Extension TM-E22-0006/Piedmont Oak Estates submitted by JIM DAVIES AND TERRI CHANG request for six (6) one-year time extensions to the approved Piedmont Oak Estates Tentative Subdivision Map (TM12-1510) resulting in a new expiration date of September 20, 2028. The property, identified by Assessor's Parcel Numbers 051-550-040, 051-550-048, 051-550-051, 051-550-058, consisting of 25.86 acres, is located on the east side of State Route 49 (SR 49), approximately 1,000 feet north of the intersection with Black Rice Road and Lime Kiln Road, in the Diamond Springs area, Supervisorial District 3.
