

RESOLUTION NO. 4927

RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF PLACERVILLE CONSENTING TO THE ESTABLISHMENT  
OF A COUNTY SERVICE AREA FOR PROVISION OF THE FOLLOWING  
EXTENDED SERVICES:

HOUSEHOLD HAZARDOUS WASTE, SOLID WASTE MANAGEMENT  
AND LIQUID WASTE MANAGEMENT, AND OTHER SUCH  
SERVICES AS MAY BE AUTHORIZED IN ACCORDANCE WITH LAW  
FROM TIME TO TIME.

WHEREAS, a county service area is proposed to be established  
pursuant to the county service area law (Sections 25210.0 et  
seq., California Government Code) in the County of El Dorado  
described generally as the entire boundary of El Dorado County  
and described particularly (Exhibit A on file in Board Clerk's  
office) and incorporated herein by reference; and

WHEREAS, the county service area, if formed, shall be known  
as County Service Area No. 10; and,

WHEREAS, the types of extended county services proposed to  
be provided within said county service area are extended  
household hazardous waste, solid waste management and liquid  
waste management and other such services as may be authorized  
by law and as may be added to these services to be performed by  
said service area from time to time by the Board of Supervisors  
in accordance with law; and

WHEREAS, the City of Placerville will benefit from many of  
these services and such county service area cannot include any  
city without its consent;

NOW, THEREFORE, BE IT RESOLVED that the City Council of the  
City of Placerville hereby consents to the formation of County

2 Commission, File No. 88-07.




The motion having a majority of votes "AYE", The Resolution was declared to have been adopted and it was so ordered.
