Hearing to consider Rosewood (Commercial Cannabis Use Permit CCUP21-0007)\* request for the construction and operation of a cannabis cultivation facility for medical and adult-use recreational cannabis. The property, identified by Assessor’s Parcel Numbers 095-130-051 & 095-130-054, consisting of 20.24 acres, is located on the west side of Derby Lane, approximately .3 mile south of the intersection with Omo Ranch Road, in the Somerset area, submitted by Jason Kipperman; Staff recommends the Planning Commission take the following actions:

- 1) Adopt the Mitigated Negative Declaration (MND) based on the Initial Study prepared by staff;
- 2) Adopt the Mitigation Monitoring and Reporting Program (MMRP) in accordance with the California Environmental Quality Act (CEQA) Guidelines Section 15074(d), incorporated as Conditions of Approval; and
- 3) Approve Commercial Cannabis Use Permit CCUP21-0007 based on the Findings and subject to the Conditions of Approval as presented. (Supervisory District 2)

**A motion was made by Commissioner Nevis, seconded by Commissioner Williams, that the Planning Commission find that based on credible lay testimony that proposed CCUP21-0007:**

- 1) Does not meet the requirements of the cannabis ordinance, particularly reduced setbacks from property lines and a bus stop due to land use conflicts, air quality impacts, and groundwater usage.
- 2) Is injurious to the public health, safety and welfare and injurious to the neighborhood due to land use conflicts, air quality impacts, traffic safety and groundwater usage.

**Due to these concerns, CCUP21-0007 is denied and the Mitigated Negative Declaration is not approved.**
