## DEPUTY CLERK OF THE BOARD I/II

### **DEFINITION**

Under immediate and general supervision, provides responsible office and ~~administrative~~secretarial support for meetings and activities of the County Board of Supervisors (Board) and associated boards, commissions, and committees, ~~and~~; assists the public in the conduct of County business; and performs related duties as assigned.

### **DISTINGUISHING SUPERVISION RECEIVED AND EXERCISED**

Receives immediate and general supervision from the Clerk of the Board of Supervisors. Exercises no direct supervision over staff.

### **CLASS CHARACTERISTICS**

*Deputy Clerk of the Board I:* This is the entry-level ~~class of this specialized classification in the Deputy Clerk of the Board series office/administrative series.~~ Initially, under close supervision, incumbents ~~with well-developed administrative skills learn County procedures and policies. As experience is gained, there is greater independence of action within established guidelines. This class is alternately staff with Deputy Clerk of the Board II, which is the journey level class of this specialized Board Clerk series. Incumbents~~ and perform ~~a wide range of specialized routine~~ clerical support duties and have frequent public contact to resolve complaints, answer inquiries and explain laws, rules, regulations and proceedings pertaining to the work of the Board of Supervisors and County government in general. As experience is gained, assignments become more varied, complex, and difficult; close supervision and frequent review of work lessen as an incumbent demonstrates skill to perform the work independently. Positions at this level usually perform most of the duties required of the positions at the II-level, but are not expected to function at the same skill level and usually exercise less independent discretion and judgment in matters related to work procedures and methods. Work is usually supervised while in progress and fits an established structure or pattern. Exceptions or changes in procedures are explained in detail as they arise.

*Deputy Clerk of the Board II:* This is the fully qualified journey-level classification in the Deputy Clerk of the Board series. Positions at this level are distinguished from the I-level by the performance of the full range of duties as assigned, working independently, and exercising judgment and initiative. Positions at this level receive only occasional instruction or assistance as new or unusual situations arise and are fully aware of the operating procedures and policies of the work unit.

This class is distinguished from the Sr. Deputy Clerk of the Board in that the latter performs the more complex office and secretarial support activities and provides lead direction to and support staff.

Positions in the Deputy Clerk of the Board class series are flexibly staffed and positions at the II-level are normally filled by advancement from the I-level, after gaining the knowledge, skill, and experience which meet the qualifications for and after demonstrating the ability to perform the work of the higher-level class.

### **EXAMPLES OF ~~DUTIES~~ TYPICAL JOB FUNCTIONS (Illustrative Only):**

- Prepares, assembles, and distributes agendas and accompanying ~~materials for material for Board, commission, and committee~~ meetings ~~of the Board of Supervisor, commissions and committees.~~
- Records, ~~transcribes,~~ and distributes official minutes of ~~Board, commission, and committee~~ meetings ~~for the Board of Supervisors, commissions and committees.~~
- Records and follows up on actions taken by the Board, including preparing ~~Minute Orders~~ motions and other actions in an official format.
- Reviews and processes a variety of Board documents such as contracts, contract change orders, notices of completion, and legal notification of meetings or public hearings.
- Establishes, maintains, and updates various files, calendars, and schedules, including following-up on matters with critical time deadlines.
- Composes correspondence independently or from brief notes, which may require interpretation of policies, procedures, and regulations.
- Provides information regarding the Board and the County to the public, County staff, and other agencies.
- Provides secretarial or related office support to Board and/or ~~Commission~~ commission members and Board staff as required.
- ~~Uses computer software to input, retrieve and prepare reports and other documents.~~
- Researches ~~historical records;~~ and compiles a variety of information and prepares reports.
- ~~Attendance and punctuality that is observant of scheduled hours on a regular basis.~~
- Performs ~~other~~ related duties as assigned.

~~Where college degrees and/or college course credits are required, degrees and college units must be obtained from an accredited college or university. Courses from non-accredited institutions will not be evaluated for this requirement.~~

~~Any combination of the required experience, education, and training that would provide the essential knowledge, skills, and abilities is qualifying.~~

~~Deputy Clerk of the Board I: ~~Three~~ Equivalent to graduation from high school and three (3) years of responsible~~ secretarial or office support experience, including experience ~~preparing~~ transcribing official records, ~~preparing~~ minutes of meetings and researching current and historical information.

Deputy Clerk of the Board II: ~~In addition~~ Equivalent to ~~the above~~, graduation from high school and one (1) year of experience providing office and ~~administrative~~ secretarial support for meetings and activities of an elected or appointed ~~Board~~ board, council, or commission at a level equivalent to the County's class of Deputy Clerk of the Board I.

### Licenses and Certifications

➤ Possession of, or ability to obtain, a valid California Driver's License by time of appointment and a satisfactory driving record.

### PHYSICAL DEMANDS

Must possess mobility to work in a standard office setting and use standard office equipment, including a computer, and to operate a motor vehicle to visit various county facilities and meeting sites; vision to read printed materials and a computer screen; and hearing and speech to communicate in person and over the telephone. Standing in and walking between work areas is frequently required. Finger dexterity is needed to access, enter, and retrieve data using a computer keyboard or calculator and to operate standard office equipment. Positions in this classification frequently bend, stoop, kneel, and reach to perform assigned duties, as well as push and pull drawers open and closed to retrieve and file information. Employees must possess the ability to lift, carry, push, and pull materials and objects up to 25 pounds with the use of proper equipment. Reasonable accommodations will be made for individuals on a case-by-case basis.

### ENVIRONMENTAL CONDITIONS

Employees work in an office environment with moderate noise levels, controlled temperature conditions, and no direct exposure to hazardous physical substances. Employees may interact with upset staff and/or public and private representatives in interpreting and enforcing departmental policies and procedures.

### WORKING CONDITIONS
