

AGREEMENT BETWEEN
THE REGENTS OF THE UNIVERSITY OF CALIFORNIA
AND
EL DORADO COUNTY

THIS AGREEMENT, is entered into this 1st day of October, 2001, by and between THE REGENTS OF THE UNIVERSITY OF CALIFORNIA on behalf of its Division of Agriculture and Natural Resources, North Region (hereinafter called "University"), and EL DORADO COUNTY, STATE OF CALIFORNIA, (hereinafter called "County").

IT IS MUTUALLY AGREED that the County will provide .50 full time equivalent funding to support a 4-H Program Representative II (described in the Exhibit A attached hereto and made a part hereof) who will provide support for the University's 4-H Program.

ARTICLE I - ALLOWABLE COST AND PAYMENT

- A. County agrees to reimburse University during the period from October 1, 2001 through June 30, 2002 in an amount not to exceed Nineteen Thousand Seven Hundred Forty-Eight Dollars (\$19,748.00) as more specifically described in the Exhibit B attached hereto and made a part hereof.
- B. Reimbursement shall be made upon execution of this agreement and submission of invoices to: Tom Soike, Interim CAO, El Dorado County 330 Fair Lane, Placerville, CA 95667.

ARTICLE II - GENERAL PROVISIONS

- A. County, and the agents and employees of County, in the performance of this agreement, shall act in an independent capacity and not as officers or agents of University.
- B. The County officer/employee to identify for administering the contract is: Chief Administrative Officer or his/her designee.
- C. Without the written consent of University, this agreement is not assignable by County either in whole or in part.
- D. No alteration or variation of the terms of this agreement shall be valid unless made in writing and signed by the parties hereto, and no oral understanding or agreement not incorporated herein, shall be binding on any of the parties hereto.
- E. It is hereby agreed by and between the parties hereto that this agreement will commence October 1, 2001 and will continue through June 30, 2002.
- F. The parties hereto agree to defend, indemnify and hold one another harmless from and against any and all liability, loss, expense, attorneys' fees, or claims for injury or damages arising from the performance of this Agreement, but only in proportion to and to the extent such liability, loss, expense, attorneys' fees, or claims for injury or damages are caused by or result from the negligent or

intentional acts or omissions of the indemnifying party, its officers, employees or agents.

The parties to the above-referenced agreement agree as follows:


