Thank you for your application to establish and administer your own merit-based personnel system for your grant-in-aid departments. We are pleased to inform you that El Dorado County is approved to administer its own local merit system based on the information you submitted in support of your application.

As a condition of CalHR's approval of El Dorado County's administration of its own meritbased personnel system, the chief executive or head of El Dorado County must sign and return the attached certification. - 1) El Dorado County will comply with the six federal principles of the Intergovernmental Personnel Act of 1970 (42 U.S.C., Sections 4728-4763) relating to prescribed standards for merit systems for programs funded under one of the nineteen statutes or regulations specified in Appendix A of the OPM's Standards for a Merit System of Personnel Administration (5 CFR 900, Subpart F).
- 2) El Dorado County is subject to audit by CalHR.
- 3) El Dorado County will maintain records of operations of its personnel management system and related human resources records in accordance with the county policy on Records Retention/Disposition Schedule passed and adopted by the County's Board of Supervisors on July 14, 2015.
