The AQMD has a large projected fund balance, \$4.66 million. Your Board continues to direct the DMV to charge fees to County residents to finance AQMD, estimated to be \$1.2 million in the next fiscal year. In view of the recent increase in gas prices and other inflationary pressures that our residents are feeling, I recommend that your Board seriously consider a County 12 month DMV fee holiday for our residents. Further, I recommend that your Board consider adopting AQMD's budget without the proposed fee increases listed on page 7 of 7 of AQMD's program summary.
