

It is my pleasure to submit the 2024 Crop and Livestock Report for El Dorado & Alpine Counties. The report is produced in accordance with Section 2279 of the California Food and Agricultural Code and summarizes the acreage, production and gross values of the Counties' agricultural commodities.

The gross crop value for the County of El Dorado was \$77.8 million in 2024, representing a decrease of 3.3% over the 2023 value. The highest value crop in 2024 was livestock, at \$21.2 million. This is a 26.3% increase over the 2023 value, and marks the second year of a steep but steady rise in beef prices. The next highest value crop was timber at \$10.8 million, reflecting an increase of 51.2% as timber harvests continue to increase following the 2021 Caldor Fire. The apple crop declined in 2024 to a value of \$12.4 million, primarily due to a dip in average yield from a massive 10.23 tons per acre in 2023 to only 4.17 tons per acre in 2024. Wine grape values declined 17.3% from \$9.75 million in 2023 to \$8.09 million in 2024. Roughly 16.5% of grape tonnage grown in 2024 was not sold or utilized. Vineyard owners reported difficulty in finding buyers for their grapes, a struggle shared by growers throughout the state. A full and detailed breakdown of the County's wine grape harvest can be found in our annual Wine Grape Survey Report.

Monetary values in this report are F.O.B. (Freight On Board) and do not reflect net returns or profits realized by the growers. It is estimated that the impact of agriculture to the County of El Dorado's economy totaled approximately \$839 million in 2024, of which, Apple Hill and value-added products contributed an estimated \$425 million while the wine industry added another \$376 million.

Alpine County's gross crop value for 2024 was estimated to be \$8.1 million. This represents an increase of 10.4% from the 2023 values.

I would like to express my sincere appreciation to the producers, agricultural business representatives and public agencies that provided information to produce this report. I would like to thank Helen Keith-Lasky and the rest of the staff for their work in compiling the report. Photos included in this report were taken by staff from the Department of Agriculture.

# El Dorado County Wine Grapes

El Dorado wine grapes are grown at high elevations in a diverse range of microclimates, perfect for cultivating a wide range of different varietals. Our strength as a wine region is in our diversity.

As of 2024, there were 82 distinct varietals planted in El Dorado County. Of these 82 varietals, 36 of them are featured on our annual Wine Grape Survey Report\*, which details the acreage, production, and price of each varietal, as well as a miscellaneous red and miscellaneous white category.

In 2024 the top 5 highest production varietals were:

- 1. Cabernet Sauvignon 1,144 tons
- 2. Zinfandel 722 tons
- 3. Merlot 424 tons
- 4. Primitivo 282 tons
- 5. Syrah 282 tons

The top 3 white varietals were:

- 1. Chardonnay 149 tons
- 2. Viognier 101 tons
- 3. Sauvignon Blanc 66 tons

#### AGRICULTURAL DEPARTMENT SUMMARY

In 2024, the El Dorado & Alpine County Agriculture, Weights & Measures Department:

### **Direct Marketing & Organics**

- Issued 71 Certified Producer's Certificates for growers selling at Certified Farmer's Markets.
- Issued 11 Farmers Market Certificates.
- Reviewed 30 Organic Registrations.

### Weights & Measures

- Inspected 541 weighing devices, that include certified producers' scales, individual farm scales, winery platform scales, and livestock scales.
- Inspected 1,786 measuring devices, retail motor fuel dispensers, electric meters, water meters, and propane gas meters. Scales and meters are inspected to ensure consumer protection and equity in the marketplace.



#### **Pest Detection & Exclusion**

- Placed 862 insect traps throughout the counties in both urban and rural areas and serviced them 3,979 times to detect and prevent the establishment of exotic and harmful pests.
- Placed 528 Glassy-winged Sharpshooter (GWSS) traps throughout the county in rural, urban, and nursery settings, inspecting and servicing them 4,768 times.
- Inspected 260 nursery stock shipments entering the county from known GWSS infected areas.

### **Other Programs**

- Provided management of wildlife that were depredating livestock, property and/or presenting a hazard to public health and safety.
- Coordinated invasive weed control, education and eradication among federal, state, county and private agencies in El Dorado and Alpine Counties. Participated as an integral partner in the El Dorado, Lake Tahoe Basin, and Alpine/Upper Carson Weed Management Area Groups.
- Conducted the Pesticide Monitoring Program to protect public health, property, the environment and agricultural workers in partnership with the California Department of Pesticide Regulation.
