### FIRST AMENDMENT TO AGREEMENT FOR SERVICES #235-S1510

**THIS FIRST AMENDMENT** to that Agreement for Services #235-S1510 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Road-Tech Safety Services, Inc., a corporation duly qualified to conduct business in the State of California, whose principal place of business is 4151 South Shingle Road, Unit 1, Shingle Springs, California 95682, (hereinafter referred to as "Lessor");

### RECITALS

**WHEREAS**, Lessor has been engaged by County to provide various types of rental equipment for the Community Development Agency pursuant to Agreement for Services #235-S1510, dated January 21, 2015, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

**WHEREAS**, the parties hereto desire to amend the Agreement to update the mailing address for invoices and to increase the not-to-exceed compensation amount of the Agreement by \$50,000, amending **ARTICLE III, Compensation for Services**;

**NOW, THEREFORE**, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Lessor mutually agree to amend the terms of the Agreement in this First Amendment to Agreement, as follows:

- I. **ARTICLE III, Compensation for Services**, paragraphs two (2) and three (3) of the Agreement are amended in their entirety to read as follows:

Itemized invoices shall follow the format specified by County and shall reference this Agreement number on their faces. Copies of documentation attached to invoices shall reflect Lessor's charges for the specific services billed on those invoices. Invoices shall be mailed to County at the following address:

or to such other location as County directs.

The total amount of this Agreement, as amended, shall not exceed \$75,000, inclusive of all costs and expenses.

Except as herein amended, all other parts and sections of Agreement for Services #235-S1510 shall remain unchanged and in full force and effect.






