RESOLUTION OF VACATION
Abandonment of Easement #07-0014
Marina Hill Amended Map, Lot 26
Assessor's Parcel Number 110-612-05
Bart Volen and Marcia Volen

WHEREAS, the El Dorado County Board of Supervisors exercises the authority established by Section 8333 of the Streets and Highways Code, which authorizes the Board of Supervisors to summarily vacate public service easements by Resolution adopted in accordance with Section 8335 of the Streets and Highways code; and

WHEREAS, public utility easements, as shown on the Marina Hill Amended Map final map, were irrevocably offered in perpetuity to the County of El Dorado in December of 1995 and accepted by the Board of Supervisors in January of 1996; and

WHEREAS, the Department of Transportation has received an application from Bart Volen and Marcia Volen, owners of Lot 26, identified as Assessor's Parcel Number 110-612-05, requesting that the County of El Dorado vacate public utility easements located on the side and rear boundary lines of Lot 26; and

WHEREAS, A T & T, Comcast, El Dorado Irrigation District, and Pacific Gas & Electric have not used said easements for the purpose for which they were dedicated or acquired; and find that no present or future need exists for said easements and do not object to their vacation; and

WHEREAS, all other existing easements will remain; and

WHEREAS, the Department of Transportation has determined that said easements herein described in Exhibit "A" and depicted in Exhibit "B", and made a part hereof, have not been used for the purpose for which they were dedicated preceding the proposed vacation, and has no objection.

NOW, THEREFORE BE IT RESOLVED, that from and after the date this Resolution is recorded, said public utility easements described in Exhibit "A" and depicted in Exhibit "B" are vacated and no longer constitute public utility easements. In addition, a Certificate of Correction is hereby authorized to be signed and may be recorded by the County Surveyor.
