**ORDINANCE NO. 5093**

THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO DOES ORDAIN AS FOLLOWS:  
RELATED TO REZONING IN THE GREENWOOD AREA, (RAY AND NAOMI DOWLER):

**Section 1.** The Official Zoning Map for the Greenwood area is hereby amended to rezone the following described lands:  
From: One-acre, Residential (R 1 A) 0.11-acre portion  
To: Commercial, Limited (CL)- 0.11-acre portion  
**Greenwood Area:**  
A 0.11-acre portion of Assessor's Parcel No. 074-173-01, being described as a portion of Section 7, T12N, R10E, M.D.M., consisting of 1.61 acres, as shown on Exhibit A hereto.

**Section 2.** This ordinance shall take effect and shall become effective thirty (30) days following the adoption hereof.


