

AGREEMENT FOR SERVICES #834 (438-S1510)  
AMENDMENT II

This Amendment II to that Agreement for Services #834 (438-S1510), made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and SCRAM of California, Inc., a California Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 402 W. Broadway, Suite 1250, San Diego, CA 92101 (hereinafter referred to as "Contractor").

**RECITALS**

**WHEREAS**, Contractor has been engaged by County to provide continuous transdermal electronic alcohol monitoring equipment (currently known as the SCRAM CAM Bracelet) with/without the house arrest component, allow access to SCRAM System Program Management Center (currently known as SCRAMNET), and provide necessary equipment and internet based software program training to staff on an "as-requested" basis for the Probation Department, in accordance with Agreement for Services #438-S150, dated June 19, 2015, and Amendment I, dated March 21, 2017, incorporated herein and made by reference a part hereof; and

**WHEREAS**, the parties hereto have mutually agreed to increase the total agreement amount of said agreement by \$80,000 for a new not-to-exceed amount of \$200,000.00, hereby amending **ARTICLE III - Compensation for Services**; and

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #834 (438-S1510) shall be amended a second time as follows:

**ARTICLE III – Compensation for Services sub-paragraph three (3) is amended and replaced in its entirety as follows:**

Total amount of this Agreement shall not exceed \$200,000.00.

Except as herein amended, all other parts and sections of that Agreement #834 (438-S1510) shall remain unchanged and in full force and effect.
