The proposed resolution to restrict dropping off students in the Cameron Park Library Parking Lot during drop/off pick up times on school days is unreasonable given the library doesn't even open until 10am, noon, or not at all, depending on the week day.

Please revise the resolution language in Section 2. Additional Regulations from during "drop off/pick up times" to during "library hours".

The resolution as written will unnecessarily cause danger and disruption along Country Club Drive during rush hour, during hours the library is closed. Furthermore it will increase traffic congestion issues in Blackstone because children from Cameron Park will now be driven to Valley View Charter Montessori in individual vehicles instead of riding a bus.
