

AGREEMENT FOR SERVICES #275-S0611 AMENDMENT I

This Amendment I to that Agreement for Services #275-S0611, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Evan B. Sundby, Ph.D, an individual, duly qualified to conduct business in the State of California, whose principal place of business is 2601 Capitol Avenue, Sacramento, CA 95816-5904; (hereinafter referred to as "Consultant");

WITNESSETH

WHEREAS, Consultant has been engaged by County to provide pre-employment and postemployement "fitness for duty" psychological examinations for the Sheriff's Office, in accordance with Agreement for Services #275-S0611, dated September 27, 2005, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to increase the compensation of said Agreement by \$900, hereby amending ARTICLE III - Compensation for Services.

NOW THEREFORE, the parties do hereby agree that Agreement for Services #275-S0611 shall be amended a first time as follows:

ARTICLE III

Compensation for Services: For services provided herein, County agrees to pay Consultant monthly in arrears. Payment shall be made within thirty (30) days following County receipt and approval of itemized invoice(s) detailing services rendered. For the purposes hereof, the billing rate shall be in accordance with the following:

- A. Pre-employment psychological screening, including rating of the pre-screening, individual clinical interview, and written report of results at \$225.00 per candidate:
- B. Post-employment psychological "fitness for duty" evaluation and report at \$100.00 per hour, per candidate:
- C. Research analysis services required beyond the pre-screening interview shall be at additional fees as negotiated between the parties on an individual case-by-case basis:
- D. Consultations including hiring meetings, training psychotherapy, court or civil service testimony shall be at an additional fee based on the rate of \$100.00 per hour.

The total amount of this Agreement shall not exceed \$24,900, inclusive of all expenses, for the two (2) year period.

Except as herein amended, all other parts and sections of that Agreement #275-S0611 shall remain unchanged and in full force and effect.
