

Please note the following problems with the Special Election for County Service Area 9, Zone of Benefit 98132, Many Oaks Lane. This is for a 3-6-12 Special Election.



Our street, Mineshaft Court, is included in this service area but our street is not physically connected to Many Oaks Lane and the service area subject of this special election. Our street, Mineshaft Court, is over one mile from Many Oaks Lane. There are three lots on Mineshaft Court that are subject to and included in this proposed assessment, but receive no benefit. Also, the service area for Many Oaks Lane knows of this problem and has not contacted or included the Mineshaft Court residents with their meetings and notification of subject action.

The residents of Mineshaft Court should not be part of this service area because we are not physically connected and we receive no direct or indirect benefits. This is unethical and inappropriate.

We are asking the El Dorado Board of Supervisors to take action and to intervene to fix this situation so it's fair and equitable. Because the Mineshaft Court residents are excluded from the proceedings of the subject service area, County Attorney should be asked for a legal opinion on the validity of this special election; therefore, we are asking the Board to declare this election invalid.


We want to bring to the attention of you and the El Dorado County Board of Supervisors specific problems with the Special Election for County Service Area #9, Zone of Benefit #98132, Many Oaks Lane. This is a March 6, 2012 Special Election.

Mineshaft Court is apparently included in this service area but our private street has no physical connection to Many Oaks Lane and the service area subject of this special election. Mineshaft Court is 1.2 miles from Many Oaks Lane. There are 3 lots on Mineshaft Court which are subject to and included in this proposed assessment but receive no benefit. In addition, the service area for Many Oaks Lane is aware of this problem and has deliberately not contacted or included the residents of Mineshaft Court with their meetings and notifications for subject action.

Mineshaft Court residents should not be a part of this service area because there is no physical connection and because they receive no direct or indirect benefit. This situation is not appropriate or ethical.

We are asking the El Dorado County Board of Supervisors to take action and to intervene to rectify the situation so it is fair and equitable. Because the residents of Mineshaft Court are specifically and deliberately excluded from the proceedings of the subject service area, County Counsel should be asked for a legal opinion on the validity of this special election. On this basis we ask the Board of Supervisors to declare this election invalid.
