I am urging you: DO NOT allow the reduction of events to 12 on Agenda Item #51 (24-1298)

I am a Wedding and Events Planner in El Dorado county. The Majority of my wedding and events take place at venues within El Dorado County. The proposed changes on Agenda Item #51 (24-1298) would drastically affect my business and all the wedding and event vendors that work in this county. It will also cause a trickle down effect on many businesses in our county which in turn will affect the county as a whole on many levels. As a wedding planner I can tell you that all my couples are coming to El Dorado County from the bay area and out of state to experience our area for their destination weddings. The average cost for a wedding in our area is \$35,000-\$50,000 and some up to \$100,000 and beyond, which goes to local venues, wedding vendors and more. The average wedding has 120-150 guests and all these people are staying locally in the hotels for usually 2-3 days during the wedding celebration and spending money in the towns local shops and restaurants. If you reduce the amount of events in half then you should expect to see many businesses in addition to our venues and wedding vendors effected by this all across the county. By Reducing the amount of events, this does not stop the wedding and event clientele from having their events, it just drives their money to other counties that do not have the same restrictions such as Placer county, Sacramento county, Napa county & Sonoma county. This will be a huge loss on so many levels and is not a decision that should be made without understanding the full effects it will have on our county as a whole.
