I think any time there is an increase in any kind of rate, there will be backlash and I understand that for many, the increasing cost of living is very hard. However, coming from a more expensive part of the state where my very tiny trash can cost twice what I pay here for half the capacity, I think perspective matters.

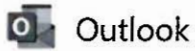
The new MRF at El Dorado Disposal is also a far better experience than the facility in Alameda. I appreciate the attention to safety, recycling, and customer service at the MRF. I also think there are a ton of free and assisted services that are provided to the community--maybe not everyone knows enough or appreciates those. They will take all of the pollution that we produce in our daily lives such as toxic household chemicals, mattresses, paint, and batteries (which cause fires when not properly disposed of!). They will pick up bulky items from your home that you may not be able to take yourself for FREE! They send out vouchers for a free dump visit and extra green waste, etc every year which, if used, offset the small rate increase. When I think about the amount of waste we all produce and how fortunate we are to have responsible and community oriented service at El Dorado Disposal, I don't think about complaining about rate increases. On top of the services they provide, they also do a lot of community outreach and donate money and time to our local agencies providing for those in need such as Big Brothers Big Sisters and Hands for Hope to name just a couple.

Unfortunately, those of us that do not feel negatively about El Dorado Disposal probably don't speak out as much as those that do but I think you'll find that most people are very happy with their service and understand that costs increase and we appreciate that those increases are kept small and are done with intention and transparency.

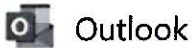
We know costs go up, and out of everything we pay for at our house, this service is the most important. A small increase each year makes sense when we get outstanding service, and we get to use the awesome new dump.
