A BILL

To make a categorical exclusion available to the Secretary of Agriculture and the Secretary of the Interior to develop and carry out a forest management activity on Federal lands to address insect or disease infestation declared as an emergency in a State by the Governor of such State, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Emergency Forest
3 Restoration Act”.

4 **SEC. 2. CATEGORICAL EXCLUSION TO ADDRESS A DE-**
5 **CLARED EMERGENCY.**

6 (a) **AUTHORITY TO CONDUCT FOREST MANAGEMENT**
7 **ACTIVITY.**—The Secretary concerned may develop and
8 carry out a forest management activity on National Forest
9 System lands or public lands in a State when the primary
10 purpose of the forest management activity is to address
11 a declared emergency.

12 (b) **AVAILABILITY OF CATEGORICAL EXCLUSION.**—
13 Except as provided in section 4, a categorical exclusion
14 is available to the Secretary concerned to develop and
15 carry out a forest management activity described in sub-
16 section (a).

17 (c) **AUTHORIZATION OF APPROPRIATIONS.**—For pur-
18 poses of this section, there is authorized to be appro-
19 priated to the Secretary concerned \$300,000,000 for each
20 of fiscal years 2017 through 2024.

21 **SEC. 3. USE OF TIMBER SALE REVENUES TO OFFSET FUNDS**
22 **APPROPRIATED TO ADDRESS A DECLARED**
23 **EMERGENCY.**

24 (a) **TIMBER SALES REQUIRED.**—

25 (1) **IDENTIFICATION OF AMOUNTS APPRO-**
26 **PRIATED.**—For fiscal year 2018 and each fiscal year

1 thereafter, the Secretary of Agriculture shall identify
2 the amount of funds, if any, appropriated in the
3 prior fiscal year pursuant to the authorization of ap-
4 propriations in section 2(c).

5 (2) SALES.—Not later than 5 years after the
6 end of the fiscal year in which an identification is
7 made under paragraph (1), the Secretary of Agri-
8 culture shall sell (in the manner provided for under
9 section 14 of the National Forest Management Act
10 of 1976 (16 U.S.C. 472a)) an amount of timber the
11 sale of which is sufficient to recoup the amount
12 identified under paragraph (1) and any costs associ-
13 ated with such sale.

14 (3) PROCEEDS.—Proceeds from the sale of tim-
15 ber described under paragraph (2) shall be deposited
16 as follows:

17 (A) An amount equal to the appropriated
18 amount identified under paragraph (1) shall be
19 deposited in the general fund of the Treasury of
20 the United States as miscellaneous receipts.

21 (B) An amount equal to the costs associ-
22 ated with the sale shall be deposited in a des-
23 ignated fund from which sums are to be used,
24 to cover the cost to the United States for de-
25 sign, engineering, and supervision of the con-

1 struction of needed roads and the cost for For-
2 est Service sale preparation and supervision of
3 the harvesting of such timber.

4 (C) Any amounts not described under sub-
5 paragraph (A) or (B) shall be deposited in the
6 general fund of the Treasury of the United
7 States as miscellaneous receipts.

8 (b) CATEGORICAL EXCLUSION.—Except as provided
9 in section 4, a categorical exclusion is available to the Sec-
10 retary of Agriculture for timber sales conducted pursuant
11 to subsection (a).

12 **SEC. 4. LIMITATION OF CATEGORICAL EXCLUSION.**

13 A categorical exclusion under this Act may not be
14 used on National Forest System lands or public lands—

15 (1) that are included in the National Wilderness
16 Preservation System;

17 (2) that are located within an inventoried
18 roadless area unless the reforestation activity is con-
19 sistent with the forest plan applicable to the area; or

20 (3) on which timber harvesting for any purpose
21 is prohibited by statute.

22 **SEC. 5. DEFINITIONS.**

23 In this Act:

24 (1) CATEGORICAL EXCLUSION.—The term “cat-
25 egorical exclusion” means an exception to the re-

1 quirements of the National Environmental Policy
2 Act of 1969 (42 U.S.C. 4331 et seq.) for a project
3 or activity relating to the management of National
4 Forest System lands or public lands that would oth-
5 erwise be considered a major Federal action.

6 (2) DECLARED EMERGENCY.—The term “de-
7 clared emergency” means an insect or disease infes-
8 tation in a State that has been declared an emer-
9 gency by the Governor of such State.

10 (3) SECRETARY CONCERNED.—The term “Sec-
11 retary concerned” means—

12 (A) the Secretary of Agriculture, with re-
13 spect to National Forest System lands; or

14 (B) the Secretary of the Interior, with re-
15 spect to public lands.

16 (4) STATE.—The term “State” means any of
17 the several States, the District of Columbia, the
18 Commonwealth of Puerto Rico, and any other terri-
19 tory or possession of the United States.
