

**AMENDMENT I FOR LEGAL SERVICES  
BETWEEN EL DORADO COUNTY AND BRADY & VINDING  
AGREEMENT #242-S1211**

This Amendment I to Agreement for legal services between El Dorado County and Brady & Vinding #242-S1211, ("Agreement"), is made and entered into between EL DORADO COUNTY ("County"), a government entity organized and existing under the laws of the State of California, and BRADY & VINDING ("Attorney"), a law firm duly authorized to do business in the State of California, whose address is 400 Capitol Mall, Suite 2640, Sacramento, California, 95814.

**RECITALS**

**WHEREAS**, County and Attorney entered into an Agreement on April 26, 2011; and,

**WHEREAS**, the parties desire to amend the Agreement to provide further specificity in Scope of Services, Billings and Contract Administrator provisions of the Agreement.

**NOW, THEREFORE**, County and Attorney mutually agree as follows:

Section 1 of the Agreement entitled, Scope of Services, is hereby amended to read as follows:

**1. Scope of Services.** County hereby retains Attorney to advise, assist, and represent County as co-counsel with County Counsel in regard to all legal aspects related to the relationship between the County and the Shingle Springs Rancheria, and any related administrative proceedings or other matters.

This shall also include advice and representation of County in regard to environmental matters to be assigned by the Contract Administrator, such as Federal actions to list the yellow-legged frog and designate critical habitat and federal action regarding forty-two roads in El Dorado National Forest.

Attorney may also provide such additional services as may be mutually agreed by the parties provided, that such additional services must be authorized in writing by the County and may require an amendment to this Agreement.

Section 6 of the Agreement entitled, Billings, is hereby amended to read as follows:

**6. Billings.** Attorney shall submit to County for County Counsel's review and approval a confidential itemized statement of services rendered and costs incurred under this Agreement monthly. Such statement shall describe the nature of the services, rendered, and specify the time expended in rendering such services, calculated in one-tenth (.10) hour segments. Provided, however, that in

Attorney's discretion, such statements need not be submitted until the total amount due exceeds five hundred (\$500.00) dollars. Contract administrator can approve travel time incurred by Attorney.

Section 16 of the Agreement, Contract Administrator, is hereby amended to read as follows:

**16. Contract Administrator.** For the purpose of administering this Agreement, the County shall be represented by its County Counsel, or successor. Notices provided pursuant to this Agreement shall be effective immediately upon receipt and shall be directed as follows:
