OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO RESOLUTION OF VACATION

Abandonment of Easement #09-0009 Cameron Park North Unit No. 8, Lot 89 Assessor's Parcel Number 082-542-09

Mark Marriott and Karen Marriott, Trustees of the 2002 Mark M. Marriot and Karen L. Marriott Revocable Trust

WHEREAS, the El Dorado County Board of Supervisors exercises the authority established by Section 8333 of the Streets and Highways Code, which authorizes the Board of Supervisors to summarily vacate public service easements by Resolution adopted in accordance with Section 8335 of the Streets and Highways code; and

WHEREAS, public utility easements, as shown on the Cameron Park North Unit No. 8 final map, were irrevocably offered in perpetuity to the County of El Dorado in June of 1968 and the Board of Supervisors accepted said offer in July of 1968; and

WHEREAS, the Department of Transportation has received an application from Mark Marriott and Karen Marriott, Trustees of the 2002 Mark M. Marriot and Karen L. Marriott Revocable Trust, requesting that the County of El Dorado vacate a ten-foot portion of the rear thirty-foot wide public utility easement for Lot 89, Cameron Park North Unit No. 8; and

WHEREAS, A T & T, Comcast, El Dorado Irrigation District, and Pacific Gas & Electric have not used said easement for the purpose for which it was dedicated or acquired and find no present or future need exists for said easement and does not object to its vacation; and

WHEREAS, all other existing easements will remain; and

WHEREAS, the Department of Transportation has determined that said easement herein described in Exhibit A and depicted on Exhibit B, has not been used for the purpose for which it was dedicated preceding the proposed vacation, and has no objection.

NOW, THEREFORE BE IT RESOLVED, that from and after the date this Resolution is recorded, said public utility easement described in Exhibit A and depicted on Exhibit B, attached hereto and by reference is made a part hereof, is vacated and no longer constitutes a public utility easement. In addition, a Certificate of Correction is hereby authorized to be signed and may be recorded by the County Surveyor.

DESCRIPTION OF PUBLIC UTILITIES EASEMENT BEING ABANDONED

All that certain real property located in the County of El Dorado, State of California, being a portion of the Northwest quarter of Section 33, Township 10 North, Range 9 East, M.D.M., more particularly described as follows:

A strip of land, ten (10') feet in width, being the Southerly ten (10') feet of the Northerly thirty (30') feet of Lot 89, as shown and so designated on the plat of Cameron Park North Unit No. 8, which filed for record in the Office of the El Dorado County Recorder on July 2, 1968, in Book E of Maps, at Page 15.

EXCEPTING THEREFROM the Westerly five (5') feet and the Easterly five (5') feet of said Lot 89.


