The County of El Dorado Planning Commission will hold a public hearing in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on August 10, 2023, at 8:30 a.m., to consider the following: General Plan Amendment, Rezone, Tentative Parcel Map GPA21-0001, Z21-0001, P21-0002/Rizzuto submitted by MICHAEL RIZZUTO to request 1) General Plan Amendment from Rural Residential (RR) to Low Density Residential (LDR); 2) Rezone from Residential Estate, Ten Acres (RE-10) to Residential Estate, Five Acres (RE-5); and 3) Tentative Parcel Map to create two (2) parcels of 5.13 acres and 5.17 acres in size from an existing 10.3-acre parcel. The property, identified by Assessor's Parcel Number 115-080-004, consisting of 10.3 acres, is located on the west side of Green Valley Road, approximately 0.6 miles northwest of the intersection with Deer Valley Road, in the El Dorado Hills area, Supervisorial District 1.
