

ORDINANCE NO. 5031

THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO DOES ORDAIN AS FOLLOWS: RELATED TO REZONING IN THE MEEKS BAY AREA (John and Kirsten Dryden):

Section 1. The Official Zoning Map for the Meeks Bay area is hereby amended to rezone the following described lands:

From:
Tahoe One-Family Residential (TR1) - 7.49 acres
Tahoe Commercial (CT) - 9.14 acres

To:
Tahoe One-Family Residential (TR1) - 15.41 acres
Tahoe Commercial (CT) - 1.22 acres

Meeks Bay Area:
Assessor's Parcel No: 016-410-10; being described as a portion of Section 29, T14N, R17E, M.D.M., consisting of 16.63 acres as shown on Exhibit A hereto.

Section 2. This ordinance shall take effect and shall become effective thirty (30) days following the adoption hereof.


