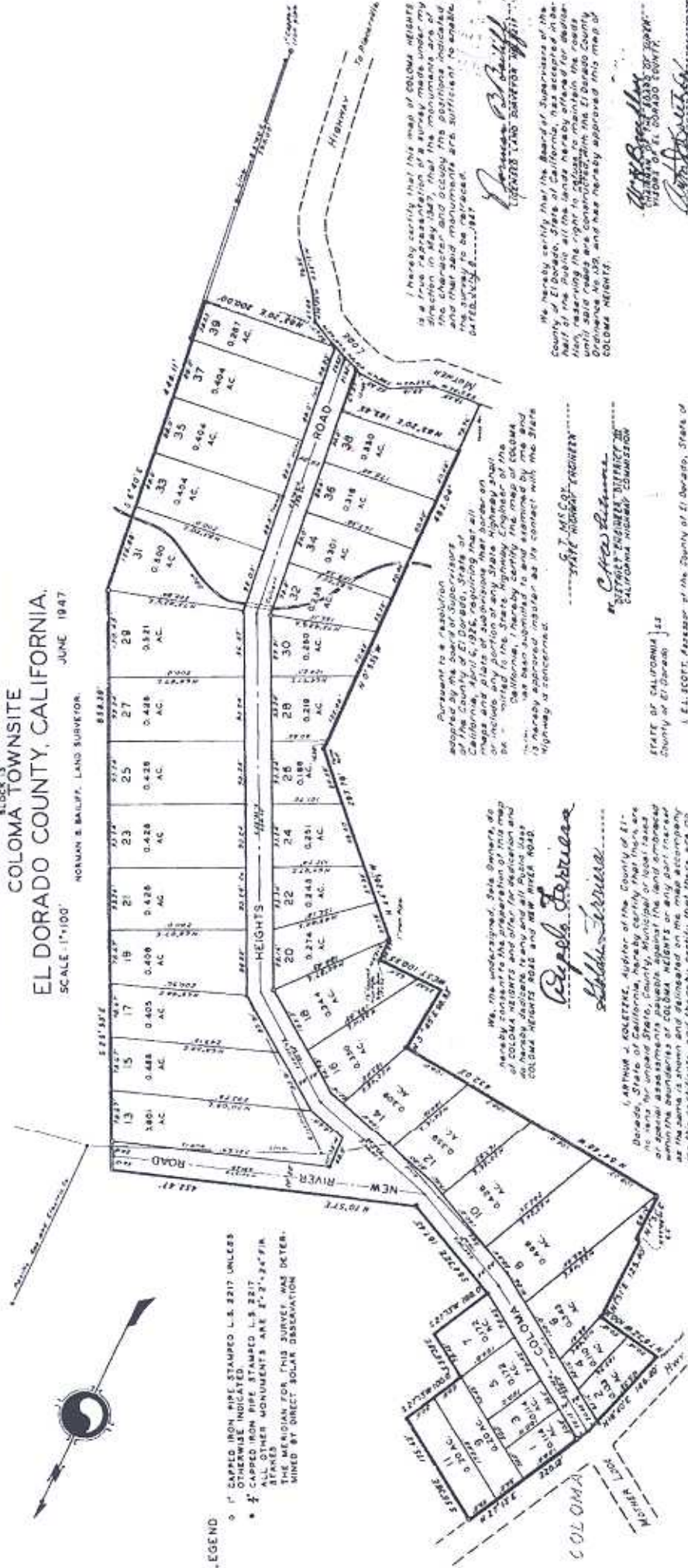


MAP OF
