Documentation of the compensation, benefits and pension for each of the current sitting Supervisors.

Documentation as to when the Logan Building's owner represented to the County that their building would be available for occupancy. (It appears that the building is under a current lease that runs until May 2014.)

Since the 60 day extension for the amendment to the Connector Financing Plan has passed, documentation that nothing was done to extend it or address the issues.

Regarding Supervisor Briggs' letter addressing the issues surrounding Supervisor Ray Nutting: Many people have approached me wondering about the "off the books" meeting that must have taken place. We want to know what happened, who was present, and why it was not documented (other than by the letter that came out of the meeting).

Dear EDC Supervisors:

Review of the minutes of the 6/4/13 BOS meeting which were sent out late Friday afternoon indicate several inaccuracies and apparent censorship of citizen voices.

I realize that meeting was out of the ordinary, very "messy" and confusing with the Nutting situation. However as a reminder the preamble to the **CA Brown Act** states:

"The people, in delegating authority, do <u>not</u> give their public servants the right to decide what is good for the public to know and what is <u>not</u> good for them to know. The people do <u>not</u> yield their sovereignty to the bodies that serve them. The people <u>insist on remaining informed</u> to retain control over the legislative bodies they have created."

Anyone reading the public minutes would be clueless as to what actually transpired at this important meeting. Whether it was by deliberate design or sheer negligence, there are several errors that need to be corrected prior to approval of the minutes during the next scheduled BOS meeting on June 11th.

In the past it has been the policy of the BOS to list the names of the speakers as well as a brief topic addressed to the BOS. For some unknown reason County Counsel and/or the CAO has deviated from this practice of transparency, accountability and the public's right-to-know as stipulated in the Brown Act preamble. As Sheriff D'Agostini said during one of our meetings, "You need a new Board of Supervisors. All of them. Hold their feet to the fire. Mine too. I work for you." Our voices must not only be heard but properly acknowledged and acted upon by our elected representatives.

I respectfully submit the following corrections:

Under Adoption & Approval of Agenda & Consent the following names were neglected to be listed under Public Comments:

Additionally the last speaker, **Francesca Duchamp**, was eliminated from the minutes. Her message is vitally important as are all the rest of the public comments.
