



**RESOLUTION NO. 085-2012**  
**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**

**Resolution to Authorize the Interim Director of Transportation to Temporarily Close Sections of El Dorado Hills Boulevard and Latrobe Road for the Construction of the U.S. 50 HOV Lanes – Phase 0 Project During the 2012/2013 and 2013/2014 Construction Seasons**

**WHEREAS**, the County plans to reconstruct the U.S. Highway 50 Off and On Ramps and sections of El Dorado Hills Boulevard and Latrobe Road for Capital Improvement Project No. 53124 during the 2012/2013 and 2013/2014 construction seasons; and

**WHEREAS**, in order to construct the Project El Dorado Hills Boulevard and Latrobe Road will need to be closed temporarily at night; and

**WHEREAS**, an alternate access route/detour will be available during the temporary closure and traffic will be directed by signage to this route/detour; and

**WHEREAS**, pursuant to California Vehicle Code Section 21101 (e), the Board of Supervisors is authorized to temporarily close a portion of any street for the safety and protection of persons who are to use that portion of the street during the temporary closing; and

**WHEREAS**, pursuant to California Vehicle Code Section 201101 (e) and California Streets and Highway Code Section 942.6, the Board of Supervisors may designate the Director of Transportation to determine the exact dates and times for the closures;

**NOW, THEREFORE, BE IT RESOLVED** that the Interim Director of Transportation is authorized to order the temporary closure of sections of El Dorado Hills Boulevard and Latrobe Road in order to reconstruct the U.S. Highway 50 Westbound Off and On Ramps and to establish an alternate access route/detour for traffic use during the time of temporary closure. The precise dates of the temporary road closures are to be determined by the Interim Director of Transportation, with notification of the pending temporary road closures and detour to be provided to the County Supervisor of District 2, business owners, residents, the general public, the El Dorado County Transit Authority and to safety and law enforcement agencies in the Project area, through direct communications, signage, or flyers.


