On October 10, 2023 (Legistar 23-1633, Item 25), the Board approved the use of \$523,593 in Shingle Springs Band of Miwok Indians Intergovernmental Agreement (Tribe) Funds for the construction of the Pony Express Trail Bicycle, Pedestrian and ADA Improvements Project, Capital Improvement Program (CIP) Number 36109010 (Project). Transportation anticipates needing \$329,202 in Fiscal Year (FY) 23/24, with the remainder being utilized in FY 24/25. This use of Tribe funds was not included in the adopted budget, so a budget transfer is needed to increase appropriations in operating transfers out and decrease contingency in the Tribe special revenue fund (SRF). At the close of Fiscal Year 22/23, \$52,294 was transferred from the SRF for Traffic Impact Fee (TIF) Silva Valley Interchange (SVI) to the Capital Improvements Org for the US 50 / Ponderosa Road Interchange - Durock Road Realignment Project, CIP Number 36104008. The funds should have been transferred from the TIF Highway 50 SRF. The error will be corrected in FY 23/24 but was not included in the adopted budget. The requested budget transfer will increase appropriations for operating transfers out by \$52,294 in the TIF Highway 50 SRF and decrease contingency by the same amount, with offsetting changes to the Capital Improvements Org and the TIF SVI SRF in the same amount. Project costs are not being increased; this transfer is only to account for the revenue correction.
