Dear Board of Supervisors:

Please consider the allocation of \$120,000 from the County's "Oak Woodland Preservation Account" to complete the acquisition of the adjoining 1,080 acres of the El Dorado Ranch (Phase 1B) fronting the Cosumnes River.

As the owner has agreed to donate \$945,000 of the property value to ARC and sell the property for \$4,995,000. The ARC expects to receive approval for a grant from the State Wildlife Conservation Board for \$4.8 million. The ARC has also secured a grant from the California Wildlife Foundation for \$75,000. This leaves a balance of \$120,000.

Spending the \$120,00 would be a prudent use of the fund as it would be used in conjunction with the State Wildlife Conservation grant and the California Wildlife Foundation grant.
