



**RESOLUTION NO.**  
**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**

*Resolution Adopting the County Proposed Budget  
And Budgets for Board Governed Special Districts  
For Fiscal Year 2007-08*

**WHEREAS,** *Chapter 1, Division 3, Title 3 of the California Government Code, beginning with Section 29000, provides the procedure for counties to follow in adopting their annual budgets; and*

**WHEREAS,** *the Chief Administrative Officer submitted the proposed FY 2007-08 budget to the Board of Supervisors on June 1, 2007 in accordance with Section 29062 of the California Government Code; and*

**WHEREAS,** *after providing due and legal notice, the Board of Supervisors has held workshops to discuss the proposed FY 2007-08 budget, during which time additions and deletions to the proposed FY 2007-08 budget were made and are incorporated herein;*

**NOW, THEREFORE, BE IT RESOLVED** *that, in accordance with Section 29063 et seq. of the Government Code, the Board of Supervisors for the County of El Dorado does hereby adopt the proposed budget for FY 2007-08 by reference of the Proposed Budget as amended by the Board of Supervisors during the budget workshops as summarized in Attachment A ("Flagged Items"), Attachment B ("Intrafund Transfers – General Fund"), and Attachment C ("Intrafund Transfers – Fund 11"); and*

**BE IT FURTHER RESOLVED,** *that, in accordance with Section 29124(a)(2) et seq. of the Government Code, the Board of Supervisors for the County of El Dorado does hereby deem appropriated the obligations related to the five new permanent employee positions (one Sheriff's Sargeant and four Sheriff's Deputies) added to the Sheriff's Office during the Board's review of the proposed budget; and*

**BE IT FURTHER RESOLVED,** *that, in accordance with Section 29124(a)(2) et seq. of the Government Code, the Board of Supervisors for the County of El Dorado does hereby deem appropriated the obligations related to the purchase of one Cisco 7206 Router in the Information Technologies budget; and*

**BE IT FURTHER RESOLVED,** *that the Board of Supervisors may make additions and changes to the proposed budget as it desires up to the time of adoption of the final budget, provided that any increase or inclusion of additional items shall not be made after the public hearing on the final budget unless proposed in writing and filed with the clerk of the board before the close of the public hearing or unless approved by the Board by four-fifths vote.*
