SECOND AMENDMENT TO AGREEMENT FOR SERVICES #6834

THIS SECOND AMENDMENT to that Agreement for Services #6834 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Michael Baker International, Inc., a Pennsylvania corporation duly qualified to conduct business in the State of California, whose principal place of business is 500 Grant Street, Suite 5400, Pittsburgh, Pennsylvania, 15219, whose local address is 3100 Zinfandel Drive, Suite 125, Rancho Cordova, California 95670 (hereinafter referred to as "Consultant").

RECITALS

WHEREAS, Consultant has been engaged by County to provide planning services for the County on an as-needed basis pursuant to Agreement for Services #6834, dated September 27, 2022, and First Amendment to Agreement for Services #6834, effective August 22, 2023, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to extend the expiration date of September 26, 2025, for two (2) additional years, amending ARTICLE II, Term;

WHEREAS, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement by \$320,000, amending ARTICLE III, Compensation for Services;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Consultant mutually agree to amend the terms of the Agreement in this Second Amendment to Agreement for Services #6834 on the following terms and conditions:

 ARTICLE II, Term, of the Agreement is amended in its entirety to read as follows:

ARTICLE II

Term: This Agreement shall become effective when fully executed by the parties hereto and shall expire five (5) years thereafter.

II. ARTICLE III, Compensation for Services, Paragraph 7, of the Article is amended to read as follows:

The total amount of this Agreement, as amended, shall not exceed \$820,000, inclusive of all Work Orders and amended Work Orders, and all costs, taxes, and expenses. It is understood and agreed that there is no guarantee, either expressed or implied, that this dollar amount will be authorized under this Agreement through Work Orders.
