## Did You Know?

- Over 900,000 children are victims of child abuse every year
- Child abuse occurs at all socio-economic, ethnic, cultural, religious and education levels
- 4 children die *every day* as a result of child abuse
- Victims are usually under the age of four
- One third of abused children become abusers, thus continuing the tragic cycle of abuse

## Foster Youth Statistics

- 50% of foster youth become homeless within the first 18 months of emancipation
- Only one foster youth in 10 attend college with fewer than 1% graduating
- 1/4 of foster youth become incarcerated within the first two years of leaving the system
- 67% of adolescent women become pregnant within 5 years of leaving the foster care system

- Limited information for Judges
- Complex overburdened system
- Another avenue of investigation
- Independent opinion
- Best interest of the child
- Superior Court Judge David Soukup's vision

#### Responsibilities of Advocates

- Extensive background screen
- Two level interview process
- 30 hours of national curriculum training
- Serve as an officer of the court
- Abidance with confidentiality
- Abidance with Local Rules of Court
- Serve solely on behalf of the child
- Cultivate a relationship of trust
- 12 CEUs annually
