

The County of El Dorado Planning Commission will hold an informational workshop in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on August 8, 2024, at 8:30 a.m., or soon thereafter, for the following project: A14-0002; Z14-0003; SP12-0001; DA14-0004; PD14-0003 / the Lime Rock Valley Specific Plan submitted by Lime Rock Valley, LLC The property, identified by Assessor's Parcel Numbers 109-010-013, 109-010-014, 109-020-001, 109-020-004, 109-020-005, 109-020-006, and 119-030-013, consisting of 800 dwelling units on 740 acres, is located in the unincorporated area of the county south of US 50, approximately 11 miles west of Placerville and 32 miles northeast of Sacramento in the Shingle Springs area, Supervisorial District 2.
