## AGREEMENT FOR SERVICES #3525 AMENDMENT II

**This Amendment II** to that Agreement for Services #3525, is made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Summitview Child and Family Services, Inc., a California non-profit public benefit corporation, duly qualified to conduct business in the State of California, whose principal place of business is 670 Placerville Drive, Suite 2, Placerville, CA 95667; (hereinafter referred to as "Contractor");

### RECITALS

**WHEREAS**, Contractor has been engaged by County to provide outpatient Specialty Mental Health Services for County-authorized Clients in accordance with Agreement for Services #3525, dated December 11, 2018, and Amendment I, dated October 25, 2019, incorporated herein and made by reference a part hereof; and

**WHEREAS**, the parties hereto have mutually agreed to amend **ARTICLE IV – Maximum Obligation**.

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #3525 shall be amended a second time as follows:

**Article IV** is hereby amended in its entirety to read as follows, and shall become effective upon execution of this Amendment 2:

**ARTICLE IV**  
**Maximum Obligation:** The maximum contractual obligation under this Agreement shall not exceed the combined total of the annual not-to-exceed amounts as set forth herein.


