OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

AUTHORIZING EXECUTION OF INTERIM AGENCY REIMBURSEMENT AGREEMENT 08-6045 WITH THE CALIFORNIA DEPARTMENT OF SOCIAL SERVICES FOR EL DORADO COUNTY'S RECEIPT OF REIMBURSEMENT, DURING THE PERIOD JULY 1, 2008 THROUGH JUNE 30, 2013, FOR INTERIM ASSISTANCE PROVIDED TO INDIVIDUALS WHO ARE SUBSEQUENTLY DETERMINED ELIGIBLE FOR SSI/SSP BENEFITS, AND AMENDMENTS THERETO

WHEREAS, The Department of Human Services administers El Dorado County's General Assistance Program to meet the basic needs of individuals residing in the County; and

WHEREAS, The California Department of Social Services (CDSS) maintains agreements with California counties to enable each county to receive reimbursement for interim assistance (General Assistance) provided to individuals who are subsequently determined to be eligible for SSI/SSP benefits during a time period when they received county financial assistance; and

WHEREAS, CDSS agreements with counties are entered into in accordance with provisions of the Agreement between the State and the Commissioner of the Social Security Administration to implement the provisions of relevant U.S. Public Law and the California Welfare and Institutions Code for the purpose of assuring the availability of reimbursement by the Commissioner to the county agencies for interim assistance paid; and

WHEREAS, CDSS has presented to El Dorado County for execution Agreement 08-6045 to replace Agreement #19011 dated July 1, 1989, reflecting changes to interim agency reimbursement requirements and forms.

NOW THEREFORE BE IT RESOLVED, that the Board of Supervisors of the County of El Dorado hereby authorizes the Chairman of the Board to execute Agreement 08-6045 with the California Department of Social Services to enable El Dorado County continue to receive reimbursement for interim assistance provided during the term of July 1, 2008 through June 30, 2013.

BE IT FURTHER RESOLVED, that the Director of the El Dorado County Department of Human Services, or successor, is hereby authorized to execute further documents relating to this Agreement, including amendments thereto, contingent upon approval by County Counsel and Risk Management, that do not affect the maximum dollar amount or the term and to sign subsequent required fiscal and programmatic reports and to perform any and all responsibilities in relationship to such Contract, as designated Contract Administrator.
