The center would be located in an unused section of the old fire station on EDH Boulevard. Part of the station is currently taken up by a Senior Center. The Day Care Center would use the back part of the building so nothing would change for the Senior Center. It was always the intention to use this area as a Day Care Center. The remodeling need to open has been completed and all of the permits have been cleared. All it is left is for the county to staff it.

There is a Day Care Center in Placerville and many people use it but at times it is over capacity. About half of the people using the current center live in El Dorado Hills, Cameron Park, Shingle Springs and Rescue. These people would be most likely to use a center in EDH. So opening the EDH Center would have an instant clientele of about 20. Because the seniors that use the Care Center pay on average about \$50 per day to use the facility a large portion of the operating cost would be covered by the enrollment fees. The onetime cost to open the facility is less than \$50,000 some of which can be covered by donations. As a result opening a Day Care facility in EDH would not increase the county budget by much.

Not surprisingly, if these caregivers also work a full-time job, many of them struggle daily with their loved ones at home and with their own challenges in the workplace. If you're currently taking care of a loved one with Alzheimer's disease or some other dementia, you already know that it significantly affects your ability to stay employed or to carry out your daily obligations to the best of your ability.

The Alzheimer's Association now estimates that last year more than 15 million workers were unpaid caregivers for people with Alzheimer's. That number is expected to grow as sufferers of the disease increase 30 percent by 2025.

Caring for someone with Alzheimer's can be extremely difficult, both physically and psychologically, especially in the more advanced stages of the disease. According to a recent report from the Alzheimer's Association, only 47 percent of people are able to keep their jobs while caring for someone with Alzheimer's. Almost 70 percent of caregivers polled said their family finances were strained, with 90 percent describing their caregiving as "emotionally stressful."

According to the Alzheimer's Association report on unpaid caregivers:

- Unpaid caregiving valued at \$210 billion is provided by family members for loved ones with Alzheimer's and other dementias.
- By 2050, caregiving costs are expected to surpass \$1 trillion.
- 69 percent of these caregivers had to arrive late to work, leave early or take time off during the day.
- 32 percent had to take a leave of absence.
- 26 percent had to take a less demanding job.
- 20 percent said their job performance suffered to the point of possible dismissal.

As an El Dorado County senior and as a member of the disabled community I am keenly aware of the growing elderly population throughout the nation and especially in our region. Understandably, this growth will place significant economic pressure upon the County. Unless planned for carefully, these stresses can have consequences from which the County cannot recover.

Ordinarily, members of the elderly and disabled populations remain independent as long as possible - preferring that life over institutionalization. Eventually, however, the latter - to varying degrees - becomes necessary.

The interim remains the challenge to El Dorado County.

Consider these facts and figures as you make your decision:

The center would be located in an unused section of the old fire station on EDH Boulevard; art of the station is currently taken up by a Senior Center. The Day Care Center would use the back part of the building so nothing would change for the Senior Center. It was always the intention to use this area as a Day Care Center. The remodeling needed to open has been completed and all of the permits have been cleared. All it is left is for the county to staff it.

There are almost 12, 000 residents in the county over 75 and this population will increase 300% by 2020. The number of people with Alzheimer's disease is expected to increase 142%.

There is a Day Care Center in Placerville and many people use it but at times it is over capacity. About half of the people using the current center live in El Dorado Hills, Cameron Park, Shingle Springs and Rescue. These people would be most likely to use a center in EDH.
