

AMENDMENT TO AGREEMENT NO. DHA-CS-ELD-01-08/A1

COUNTY OF SACRAMENTO

THIS FIRST AMENDMENT is made and entered into this _____ day of _____, 2008, by and between the COUNTY OF SACRAMENTO, a political subdivision of the State of California, hereinafter referred to as "COUNTY", through the COUNTY agent known as the SACRAMENTO COUNTY DEPARTMENT OF HUMAN ASSISTANCE, hereinafter referred to as "DEPARTMENT" and the COUNTY OF EL DORADO, a California corporation, hereinafter referred to as "CONTRACTOR".

RECITALS

WHEREAS, COUNTY and CONTRACTOR previously entered into an agreement on January 1, 2008, to provide HOPWA Short-Term Rent, Mortgage, and Utility (STRMU) assistance to persons with HIV/AIDS, hereinafter "Agreement"; and

WHEREAS, COUNTY and CONTRACTOR desire to formally amend said Agreement Scope of Services to increase the number of clients to 57 and the Budget for \$10,000 additional funding; and

WHEREAS, DIRECTOR of DEPARTMENT is authorized to enter into this Amendment on behalf of COUNTY by Resolution No. 2008-0259.

NOW, THEREFORE, the Agreement is amended as follows:

I. **SCOPE OF SERVICES**

Section IV. DESCRIPTION OF SERVICES, paragraph A of Exhibit "A", will be changed to read:

A. CONTRACTOR shall provide short-term rent, mortgage and utility payment assistance to fifty-seven (57) unduplicated eligible participants and their families utilizing U.S. Department of Housing and Urban Development (HUD) Housing Opportunities for Persons with AIDS (HOPWA) funds.

II. **CONTRACT REIMBURSEMENT**

Exhibit "C" attached to the Agreement is hereby amended as reflected by Exhibit "C-1" to this Amendment and is made part of the Agreement.

III. **REAFFIRMATION**

In all other respects, the above referenced Agreement, as amended, remains in full force and effect.

IV. **ENTIRE AGREEMENT**

The Agreement, as amended, and any attachments hereto, constitute the entire understanding between the COUNTY and CONTRACTOR concerning the subject matter contained herein.

V. **EFFECTIVE DATE**

The Amendment shall be deemed effective as of the date first written above.
