PURPOSE/OBJECTIVE OF COMMISSION

Purpose and Role

- The Behavioral Health Commission is established under Welfare and Institutions Code (WIC) 5604.
- WIC 5604.2 states the Commission's duties to "Review and evaluate the community's mental health needs, services, facilities, and special problems."
- The Commission serves in an advisory role to the Board of Supervisors.
- The Behavioral Health Commission (BHC) Bylaws were updated and approved by the Board of Supervisors on February 11, 2025. (Resolution 019-2025.)
- BHC Bylaws Article IV. The Behavioral Health Commission shall "Review and evaluate behavioral health needs, services, facilities and special problems in any facility within the county or jurisdiction where mental health or substance use disorder evaluations services are being provided."

Objectives

- Review and advise on any county agreements entered into pursuant to California WIC Section 5650 (Performance Contract.)
- Advise the Board of Supervisors and the El Dorado County Behavioral Health Director as to any aspect of the local behavioral health program.
- Review and approve the procedures used to ensure citizen and professional involvement at all stages of the planning process as specified in California WIC Section 5651.
- Review each qualified applicant for the position of Behavioral Health Director, and make recommendations to the Board of Supervisors. The Commission shall be included in the selection process prior to the vote of the Board of Supervisors.
